

**Waiver of Liability, Release
Assumption of Risk & Indemnity Agreement
(Flow Arts Institute, CampFire)**

It is the purpose of this agreement to exempt, waive and relieve releases from liability for personal injury, property damage, and wrongful death--including if caused by negligence, including the negligence, if any--of the CampFire Organization, hereby referred to as the releases. "The CampFire Organization" includes Flow Arts Institute, their officers, directors, advisers, agents, employees, volunteers, vendors, their event hosts, and other participants.

For and in consideration of the undersigned participant being allowed to participate in the CampFire event, related workshops or activities, the participant (and the parent(s) or legal guardian(s) of participant, if applicable) waive, release and relinquish any and all claims for liability and cause(s) of action, including for personal injury, property damage or wrongful death occurring to participant, arising out of participation in CampFire sponsored or funded events or activities, whenever or however they occur and for such period as said activities may continue. The CampFire Organization makes no representations, warranties, guarantees or conditions of any kind, express or implied, regarding the content of workshops, the level of fire safety, the availability of medical care, or any of the services provided at the CampFire event, or that the undersigned participant may use through participation in the CampFire event, all of which are provided on an "as is" basis.

Participant (and participant's parent(s)/guardian(s), if applicable), hereby collectively referred to as "the named participants" acknowledge, understand and assume all risks relating to attending the CampFire event, related activities, and that such activities could involve certain risks to participant's person including bodily injury. These risks and dangers may be caused by the negligence of the named participants or the negligence of others, including the "releases" identified above. The named participants acknowledge, understand and agree that all of the risks and dangers described throughout this agreement, including those caused by the negligence of the named participants and/or others, are included within the waiver, release and relinquishment described above. The named participants further acknowledge that there may be risks and dangers not known to the CampFire Organization or not reasonably foreseeable at this time.

The named participants acknowledge that activities at the CampFire event include PHYSICAL CONTACT WITH FIRE, in potentially hazardous conditions which may include, among other things, strong winds or dry brush, close proximity to moving or stationary hazardous objects such as open flames, combustible fuels, close proximity to other participants wielding hazardous objects, or custom fabricated equipment designed to propel flaming objects at high velocity.

PARTICIPANT (AND PARTICIPANT'S PARENT(S)/GUARDIAN(S), IF APPLICABLE) ACCEPT ANY AND ALL RISKS TO MY CHILD OF INJURY, DEATH, AND PROPERTY DAMAGE ARISING FROM PARTICIPATION IN THE ACTIVITIES AND THE USE OF THE FACILITIES AND PROPERTY OF THE CAMPFIRE EVENT, AND HARMONY PARK, WHETHER OR NOT CAUSED BY THE NEGLIGENCE OR OTHER ACTION OF ANY OF THE RELEASES.

The named participants acknowledge that they have been provided and have read the above paragraphs and have not relied upon any representations of releases and understand these waivers and releases are necessary to allow the CampFire Organization to hold and/or sponsor events for the participants. I/We agree to abide by and be bound any and all rules or regulations required by the CampFire Organization.
